

**JESSIE'S ALOHA HOLIDAYS SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING. MANY WILL ENTER. FEW WILL WIN.**

**1. SPONSOR:** ABC Cable Networks Group, dba Disney Channel ("Sponsor"), 3800 W. Alameda Avenue, Burbank, CA 91505.

**2. ADMINISTRATOR:** Ventura Associates International LLC ("Administrator"), 60 East 42nd Street, New York, NY 10165, an independent judging organization whose decisions are final and binding with respect to the sweepstakes.

**3. ELIGIBILITY:** Open only to persons who are, as of Entry, 6 to 16 years of age, legal residents of, and physically located within, the 50 United States or D.C. ("Territory") and not employees of Sponsor or Administrator, their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (individually and collectively, "Entities"); nor members of their households or immediate families. Void where prohibited or restricted by law and subject to all applicable federal, state, local and municipal laws and regulations.

**4. ENTRY:** Jessie's Aloha Holidays Sweepstakes ("Sweepstakes") may be entered via the Internet by a registered member ("Member") of Disney.com, during the period commencing at 12:01 A.M.(PT), November 28, 2014, and ending at 12:01 A.M.(PT), November 29, 2014 ("Entry Period") by watching Disney Channel's "Jessie's Aloha Holidays with Parker & Joey" ("Show") and answering a multiple choice question as follows: **[1]** Tune into Disney Channel on November 28, 2014 to watch the Show, **[2]** count how many "Aloha's" are stated in the Show, then **[3]** visit DisneyChannel.com/Aloha ("Website") during the Entry Period, log in with your Member name and password to enter your correct answer ("Answer"), and complete your entry into the Sweepstakes ("Entry"). If you are not a Member, you may become a Member for free by visiting the Website and registering by providing the requested information on the Registration Form through the link on the site: "Not registered?" Upon becoming a Member by registration, you may enter the Sweepstakes by following the above instructions. Parent or legal guardian ("Parent") of a child under the age of 13 will be sent an email notifying him/her of the child's registration and Entry into this Sweepstakes. No response by the Parent to the email is required for the child to enter; however, if the Parent does not want his/her child to enter, Parent may click on a link in the email and complete the steps required to cancel the child's Entry and delete the child's information. If you do not give the correct Answer, you will be asked to try again until you do answer correctly. If you miss the Show, you may visit DisneyChannel.com/Aloha to obtain the Answer. See local listings for local times for the Show. Normal Internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Administrator if you or your Parent

change email address (“Address”). To do so, go to <http://register.go.com/go/memberservices/home>, log into your Website account with your Member Name and Password, click on “Modify” and follow the instructions on how to change the Address. For purposes of these Official Rules (“Rules”), all times and days are Pacific Time (“PT”). Sponsor's computer is the official time keeping device for this Sweepstakes; and the awarding of any prizes is subject to the eligibility and forfeiture provisions set forth below.

**5. LIMITATIONS:** All Entries must be received by 12:01 A.M. PT, November 29, 2014. Entries are limited to one (1) Entry per person per email address (“Address”) during the Entry Period regardless of whether one person has more than one Address or more than one person use the same Address. In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the Address is registered. Entries by any method other than set forth above in Paragraph 4 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, “Releasees”) are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone, computer hardware or software or telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in entrant’s email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified and any attempt by a person to use multiple email accounts to register more than the number of Entries allowed by these Rules may result in disqualification at Sponsor’s sole discretion.

**6. PRIZES: THREE (3) GRAND PRIZES (“Grand Prize”)** are available to be awarded in this Sweepstakes. Grand Prize consists of a five (5) day / four (4) night trip for winner (“Grand Prize Winner”) and three (3) companions (each companion individually, a “Guest” or “Guests”), collectively the Guests and Grand Prize Winner may be collectively referred to herein as the “Group”) to Honolulu, HI (“Trip”). Grand Prize consists of the following elements: **[a]** hotel accommodations at Aulani, a Disney Resort & Spa in Ko Olina Hawai’i (one (1) standard room/quad occupancy, including room tax) for four (4) consecutive nights; **[b]** if Grand Prize Winner’s residence is located other than on the Island of Oahu, round-trip coach air transportation on a Sponsor-selected carrier between a Sponsor-selected major metropolitan airport near Grand Prize Winner’s residence (“Airport of Origin”) and the Honolulu International Airport; **[c]** if air transport is provided, airport/hotel transfers. Approximate retail value

("ARV"): **\$5,204** which will vary depending upon point of departure and seasonal fluctuation of hotel rates and airfares. Total ARV of all Grand Prizes: \$15,612. Travel is subject to the restrictions and conditions set forth herein. All expenses not specifically mentioned herein are not included and are solely the Grand Prize Winner's responsibility, including but not limited to: round trip transportation between the Grand Prize Winner's residence and any Airport of Origin, round-trip transportation between Grand Prize Winner's residence and the hotel if Grand Prize Winner resides on the Island of Oahu, alcoholic and non-alcoholic beverages, fax, food, gratuities and tips, insurance, laundry service, merchandise, parking, room service, service charges, excursions, souvenirs, spa services, telephone calls and some additional taxes which are not expressly included in the Trip. **Grand Prize Winner must provide a minimum of forty-five (45) days advance notice of desired departure and all travel must be completed by 9/15/15 or the Grand Prize will be forfeited in its entirety and no additional prize element substituted.** Travel and lodging are subject to availability, certain restrictions, holiday blackout dates and Sponsor's approval. Blackout dates include December 15, 2014 – January 5, 2015 and holiday weekends (determined by Sponsor at their sole discretion). Airline carrier and hotel regulations and conditions apply. The actual value of the Grand Prize may vary depending on city of departure, date and times of travel, airfare fluctuations and Resort charges at the time of travel booking. Therefore, the actual value of the Grand Prize awarded may be lower or higher at the time it is fulfilled. If the actual value of the Grand Prize is less than the stated ARV, the difference will not be awarded. Any depiction of the Grand Prize is for illustrative purposes only. Grand Prize is not redeemable for cash or transferable. No substitution of the Grand Prize or any portion thereof allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. Sponsor reserves the right at its sole discretion to substitute the Grand Prize or any portion thereof with another prize of equal or greater value (or cash equivalent) in the event that the Grand Prize (or any component thereof) is not available. Sponsor will not replace any lost, mutilated or stolen tickets, travel vouchers or certificates. Grand Prize elements may not be separated. Airline tickets issued in conjunction with the Grand Prize are not eligible for frequent flyer miles, and no code share flights may be used. No one-way trips or upgrades allowed. Unless otherwise necessitated by Sponsor, no stopovers are permitted on tickets issued as the Grand Prize; if a stopover otherwise occurs, the Grand Prize will terminate and full fare will be charged from the stopover point for the remaining trip segment(s), including the return. Once hotel accommodations and flight arrangements have been confirmed, no changes will be allowed except by Sponsor. Grand Prize Winners are solely responsible for any and all excess baggage charges, taxes and any other charges incurred after or in connection with the issuance of airline tickets. Grand Prizes cannot be used in conjunction with any other promotion or offer. All travel arrangements are to be administered by Sponsor or its designee and Sponsor shall determine airline and flight itinerary in its sole discretion. Group will be required to travel on identical itineraries including the same departure city and date, destination and return date. A Minor may not participate in the Trip unless accompanied by his/her Parent, who shall count as one of the allotted members of the Group. Each member of the Group will be required to provide a valid government issued photo ID at time of travel. Photo identification and credit card or cash deposit may be required at check-in

for incidental charges (e.g., room service, use of telephone/IT services, laundry and all other optional extra services not provided in the prize). If Grand Prize Winner elects to travel or partake in the Trip with no Guest or fewer than three (3) Guests, no additional compensation will be awarded. Air transportation, ground transfers, and accommodations must be taken together and cannot be taken separately.

All taxes (including, without limitation, state and federal income taxes) and the reporting consequences thereof associated with the use and acceptance of the Grand Prize is solely the responsibility of the Grand Prize Winner, who will receive an IRS Form 1099 reflecting the Grand Prize value. All Grand Prizes will be awarded provided a sufficient number of eligible Entries are received and Grand Prizes are validly claimed by March 30, 2015, after which no alternate Grand Prize Winners will be selected, nor unclaimed Grand Prizes awarded.

**7. PROCEDURES:** Entries will only be accepted during the Entry Period. On or about December 4, 2014, in a random drawing under the supervision of the Administrator, three (3) potential Grand Prize Winners will be selected from all eligible Entries received. Odds of winning depend on the total number of eligible Entries received.

**8. WINNERS:** On or about December 5, 2014, the potential Grand Prize Winners will be contacted by email to secure mailing address ("Email Contact"). Once mailing address is available, potential Grand Prize Winners will be sent paperwork by overnight delivery service. All legal responsibilities under the Rules of a Minor will be assumed by a Parent; and if Grand Prize is won by a Minor, it will be awarded in the name of the Parent for the benefit of the Minor. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Grand Prize Winner may result from any of the following: **[1]** potential Grand Prize Winner's failure to respond to Email Contact within 3 calendar days after emailing by Administrator; **[2]** the return of any notice as undeliverable; **[3]** a potential Grand Prize Winner's failure to provide Administrator with satisfactory proof that he/she is the authorized account holder of the Address associated with the winning Entry; **[4]** a potential Grand Prize Winner's failure to provide required additional information upon Administrator's request; **[5]** potential Grand Prize Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; **[6]** potential Grand Prize Winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release within five (5) business days after its mailing; **[7]** the potential Grand Prize Winner's failure to be available to take the Trip before September 15, 2015; **[8]** potential Grand Prize Winner's failure to validly claim the prize by March 30, 2015, and **[9]** any other non-compliance with Rules. In the event of any prize forfeiture, the Sponsor may, in its sole discretion, award or not award the forfeited prize to an alternate Grand Prize Winner.

**9. PRIVACY POLICY/DATA COLLECTION:** All personal information provided by you for this Sweepstakes is subject to Sponsor's privacy policy located at <https://disneyprivacycenter.com> ("Privacy Policy").

**10. CONDITIONS:** By entering this Sweepstakes and/or accepting any Grand Prize you may win, you agree, represent and warrant that: **[1]** you have all rights, permissions and consents necessary to grant the rights to Sponsor as expressed herein; **[2]** you will abide by and be bound by the Rules and the Sponsor's decisions and Privacy Policy; **[3]** the Entry becomes solely the Sponsor's property and will not be acknowledged or returned; **[4]** you release and hold harmless the Releasees from any and all liability for claims, injuries, losses or damages of any kind, including without limitation, death and bodily injury, resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of the Grand Prize; participation in the Sweepstakes or any Sweepstakes-related activity or travel or from any interaction with, or downloading of, computer Sweepstakes information; **[5]** the Grand Prize is awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied, (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose); **[6]** Grand Prize Winner's acceptance of the Grand Prize constitutes the grant to Sponsor and assigns of an unconditional right to use Grand Prize Winner's name, address (city and state only), voice, likeness, photograph, biographical and Grand Prize information and/or statements about the promotion for any programming, publicity, advertising and promotional purposes without additional compensation, except where prohibited by law; **[7]** in the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental or supra-national authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Sweepstakes, so that it cannot be conducted as originally planned, Sponsor has the right, in its sole discretion, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes; and in such event, to select Grand Prize Winners by such method as Administrator in its sole discretion shall consider equitable and in the event the Trip has already commenced, to terminate the Trip and return the Group to any Airport of Origin as soon as reasonably possible; **[8]** the Releasees are not responsible for typographical or other errors in the offer or administration of this Sweepstakes, including but not limited to: errors in the advertising, Rules and selection and announcement of the Grand Prize Winners; **[9]** any portion of the Grand Prize not accepted or used by the Grand Prize Winners will be forfeited; **[10]** the Releasees are not responsible for any inability of the Grand Prize Winners to accept or use the Grand Prize (or any portion thereof) for any reason; **[11]** the Sponsor has the right, at any time and at its sole discretion, to disqualify any individual it suspects to be doing any of the following: **(a)** tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or the Website; **(b)** violating the Rules; **(c)** violating the terms of service, Privacy Policy or other terms, conditions of use and/or general rules or guidelines of any Sweepstakes property or service or **(d)** acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person; or for any other good cause as determined solely by the Sponsor; **[12]** Sponsor has the right to lock out an entrant whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter the Sweepstakes; **[13]** since any attempt by any individual to damage the Website or undermine the legitimate operation of this Sweepstakes or the Website is a violation of these Rules as well as

criminal and civil laws, and should Sponsor believe or become aware that such an attempt has been, is being, or will be made, it has the right to seek remedies and damages from any responsible individuals to the fullest extent permitted by law, including without limitation criminal prosecution; **[14]** all disputes, claims and causes of action at law or in equity (individually, "Claim") arising out of or relating to this Sweepstakes, the meaning or interpretation of the Rules or any Grand Prize awarded shall be resolved by applying the laws of California, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in the state or federal courts within that state; **[15]** all Claims shall be resolved individually, without resort to any form of class action; **[16]** all Claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event include attorneys' fees, and under no circumstances will any entrant be permitted to obtain awards for, and hereby waives all rights to claim, punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses and waives all rights to have damages multiplied or otherwise increased; **[17]** Sponsor has the right to modify Grand Prize award procedures at its sole discretion; **[18]** Grand Winner's acceptance of the Grand Prize constitutes the grant of an unconditional right to Sponsor and assigns to photograph, film, or otherwise capture the fulfillment of the Grand Prize ("Fulfillment Filming"), and Sponsor shall have the unconditional right to reproduce, distribute, display, exhibit, transmit, broadcast, stream, synchronize with visual material, modify, amend, create derivative works, and otherwise use and permit others to use the Fulfillment Filming throughout the universe in any and all media now known or hereafter devised, in all languages and in all versions, in perpetuity, without compensation, except where prohibited by law; **[19]** Sponsor's use of the Fulfillment Filming will not give rise to any claims of infringement, invasion of privacy, defamation or claims for performance or payment of any kind, including but not limited to payment of re-use fees, residuals or license fees; **[20]** Sponsor shall have the right to make such changes to the Fulfillment Filming and make such uses thereof as it deems necessary or desirable, including but not limited to the right to use, edit, and reproduce and/or alter the Fulfillment Filming in perpetuity, in its entirety or in part, for any commercial and promotional purposes worldwide without any consultation or additional permission, or compensation, credit or attribution; **[21]** Administrator has the right to conduct a background check ("Check") of any and all records of each member of the Group, including without limitation, civil and criminal court records and police reports, which he/she, to the extent necessary under law, shall authorize; **[22]** Administrator may take all steps necessary to corroborate any information provided and each member of the Group will be obligated to provide necessary contacts and information for the Check; **[23]** if any member of the Group is found to have a felony conviction, Administrator has the right, in its sole discretion, to disqualify the felon from participating in the Trip and to pay the Grand Prize Winner a cash substitute for the Trip, but no cash substitute will be paid to any Guest; if a felony conviction is found, Administrator retains the right to also continue the award of the Grand Prize to Grand Prize Winner and other Guests, and **[24]** the Trip cannot be sold, nor can a Grand Prize Winner charge members of his/her Group for participating in the Grand Prize.
